



ISCOVER

PLAY

Edgewood Country Club allows you to experience a truly unique game of golf. You'll encounter a variety of golf holes which include deep sand bunkers, beautifully groomed fairways framed by overhanging trees, gentle elevation changes, subtle contours and water. At 6,420 yards from the tips, Edgewood's par 71 layout is challenging yet player friendly. Remodeled in 2016, the practice facilities contain 12 new artificial turf range mats and a large grass tee along with a large short game area, putting green and practice bunker.

The Junior Golf Program accommodates children ages 7-17. The programming is based around golf fundamentals and activities designed to bring families together and socialize.

Edgewood Country Club's pool is home to the Edgewood Eels, a MISCA swim team. The swim team is open to children of members ages 7-17.

After the preview term, the preview relationship will be terminated unless the applicable initiation fee is paid in full at that time

Seasonality Element

We recognize that this marketing initiative is being introduced during fall.
