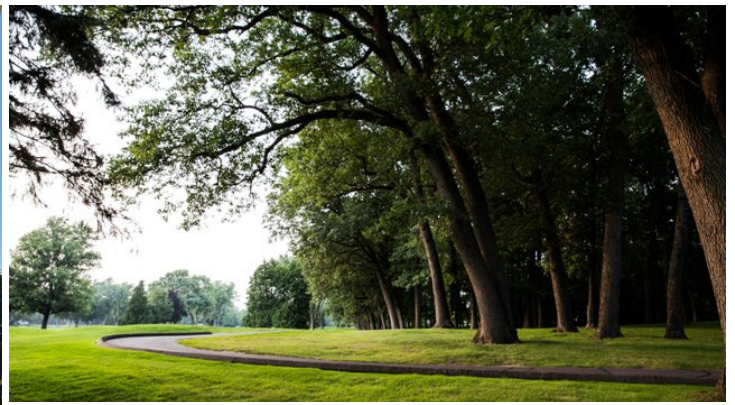

The Junior Golf program accommodates children ages 7-17 and is based around golf fundamentals and activities designed to bring families together and socialize.

With an award-winning Executive Chef and our friendly staff, Edgewood Country Club offers both casual and fine dining. Our extensively trained culinary team will keep you coming back for more with seasonal menus and the highest quality of food served.

Our heated outdoor pool is the place to be during the summer months with the new "Edge Bar" opening in 2021. The Eels Swim Team also provides a great swim experience for all families.

## YOUNG EXECUTIVE

---

Available to applicants between the ages of 21 - 37. Membership provides full access to all of the Club's facilities and amenities to include the 18-hole championship golf course, practice facilities, pool, fitness center, clubhouse, dining, and all social related events and activities.

(PLEASE NOTE: Per the Edgewood Country Club By-Laws, terms of a Young Executive golf member shall not continue after the thirty-seventh (37) birthday of member.)  
(Once eligibility for Young Executive has expired, a \$1,000 transfer fee will be required to move to Class A membership)

(PLEASE NOTE: Per the Edgewood Country Club By-Laws, proof of Homestead is required for eligibility as Non-Resident member.)

# **DISCOVER EDGEWOOD COUNTRY CLUB**

We would like you to experience, first-hand, everything we have to offer at Edgewood Country Club. Our goal is to prove to you that you belong here and that we will do everything we can to make you feel right at home.

You will have the privilege of "previewing" the club through May 31, 2023, without the payment of an initial initiation fee. During your preview term, you will be obligated to pay dues and fees applicable to the category of membership in which you are approved.

While you are enjoying the club during your preview term, we want to give you an opportunity to enjoy a preferred initiation fee. If you decide to purchase your membership at any time before June 30, 2022, you will enjoy the preferred initiation fee listed below:

To enjoy the preferred initiation fees, as represented above, payment must be made to the club on or before June 30, 2022. After June 30, 2022, the reductions listed above will no longer be available. In the event you do not pay the initiation fee on or before June 30, 2022, your preview membership relationship shall continue through May 31, 2023. After the preview term, the preview relationship will be terminated unless the applicable initiation fee is paid in full at that time.

## **SEASONALITY ELEMENT**

We recognize that this initiative is being introduced during the winter. Rather than suggesting waiting until spring to consider joining Edgewood Country Club, we are offering a modified dues structure from the beginning of the program through April 30, 2022. All individuals who apply and approved for membership during this time will enjoy 50% dues through April 30, 2022. Beginning May 1, 2022, you will begin to pay full dues and fees applicable to your membership classification. New members who join after May 1, 2022 will begin to pay dues and fees applicable to their membership category, commencing on the 1st of the month, following approval of membership application.

***(Please Note: Monthly incentive credits start when full dues begin.)***

## **SELECTED SURROUNDING AREA CLUB DISCOUNT**
