A complete bunker renovation was completed in 2020 and practice facilities, were remodeled in 2016 adding a large short game area, putting green and practice bunker.

With an award-winning Executive Chef and our friendly staff, Edgewood Country Club offers an excellent casual and fine dining experience. Our extensively trained culinary team will keep you coming back for more with seasonal menus and the highest quality of food served and craft cocktails.

Our heated outdoor pool is the place to be during the summer months with the new "Edge Bar" opened in 2021. The Eels Swim Team also provides a great swim experience for all families.

We are thrilled to announce the completion of our state-of-the-art golf services building which includes a new pro shop as well as three Trackman golf simulators giving our members year round opportunities to golf.

But that's not all - exciting times lie ahead as we embark on our next series of improvements to further elevate Edgewood Country Club in 2024. This project will update nearly the entire clubhouse with a two-lane covered entryway, new lobby, reception area, office, conference room, mansard roof and a lower building enclosure remodel to update the exterior look of the clubhouse.

YOUNG EXECUTIVE

Available to applicants between the ages of 21 - 37. Membership provides full access to all of the Club's facilities and amenities to include the 18-hole championship golf course, practice facilities, pool, fitness center, clubhouse, dining, and all social related events and activities.

(PLEASE NOTE: Per the Edgewood Country Club By-Laws, terms of a Young Executive golf member shall not continue after the thirty-seventh (37) birthday of member.)

(Once eligibility for Young Executive has expired, a \$1,000 transfer fee will be required to move to Class A membership)

<u>INITIATION FEE:</u> \$12,000 <u>MONTHLY DUES:</u> \$445.25

PREFERRED OPTION: \$9,500 MONTHLY CAPITAL DUES: \$91

PROMOTION: New members will enjoy a \$45 monthly credit through December 31, 2025!

JUNIOR LEGACY

Available to applicants between the ages of 21 - 37 who are children of current club members. Membership provides full access to all of the Club's facilities and amenities to include the 18-hole championship golf course, practice facilities, pool, fitness center, clubhouse, dining, and all social related events and activities.

<u>INITIATION FEE:</u> \$3,000 <u>MONTHLY DUES:</u> \$239.75

PREFERRED OPTION: \$2,000 MONTHLY CAPITAL DUES: \$49

PROMOTION: New members will enjoy a \$20 monthly credit through December 31, 2025!

NON-RESIDENT GOLF

Available to applicants who maintain a primary residence outside of 100-mile radius of the club. Membership provides access to all of the club's facilities and amenities to include the 18-hole championship golf course, practice facilities, pool, fitness center, clubhouse, dining, and all social related events and activities.

(PLEASE NOTE: Per the Edgewood Country Club By-Laws, proof of Homestead is required for eligibility as Non-Resident member.)

THE CLASS A PREFERRED INITIATION FEE OF \$15,000 IS ONLY AVAILABLE UNTIL JUNE 1, 2024. FIRST INSTALLMENT PAYMENT FOR THE CLASS A INTIATION FEE IS REQUIRED WHEN SUBMITTING MEMBERSHIP APPLICATION.

To enjoy the preferred initiation fees, as represented above, payment must be made to the club on or before July 31, 2024. After July 31, 2024, the reductions listed above will no longer be available. In the event you do not pay the initiation fee on or before July 31, 2024, your preview membership will continue through May 31, 2025. After the preview term, the membership will be terminated unless the applicable initiation fee is paid in full at that time.

SELECTED SURROUNDING AREA CLUB DISCOUNT:

Edgewood Country Club is also offering a reduced initiation fee for prospective members who are current members of selected, surrounding area private clubs.
